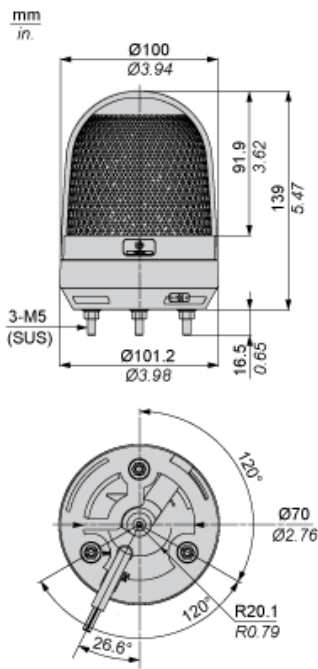

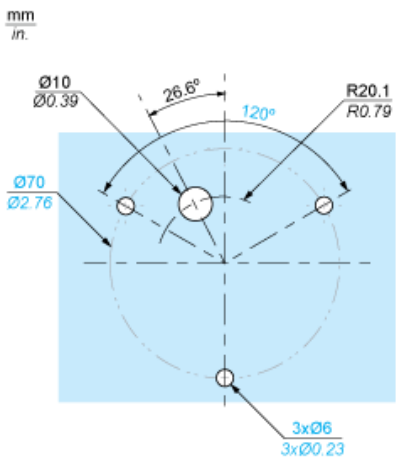

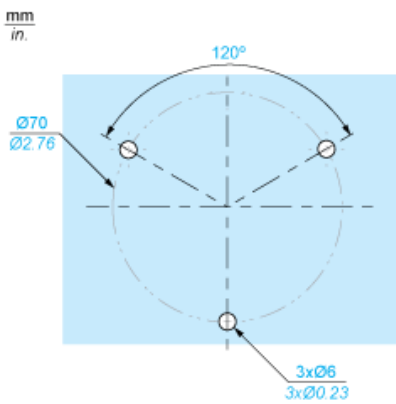


Panel Cut-out

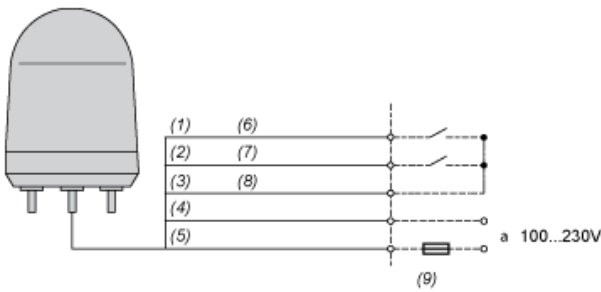
Straight wiring
